- _____ 1. **Disclosures:** Please contact the VBOA by email at boa@boa.virginia.gov if you need to disclose any information regarding a felony or misdemeanor conviction, an administrative action, or civil judgment.
- _____ 2. **Fees:** The renewal fee is \$75 if the firm license expires prior to June 30, 2018.
Fee for using a non-online method: \$25

The renewal fee is prorated for firms with a CPA license expiring July 2018 through March 2019. The adjusted fees are listed below.

Upon renewal and moving forward, the firm expiration date will be June 30 for subsequent years.

There is no additional 12-month period to renew your license. Unrenewed firm licenses will automatically go into Expired status the day after the renewal is due. If you choose not to use the online payment method, the VBOA accepts payment by check or money order made payable to the Treasurer of Virginia. Fees can be used for one year from date of receipt. Pursuant to [18VAC5-22-20\(B\)](#), all fees are non-refundable. Your application will not be reviewed until you have submitted payment. Once the license goes into Expired status, it will be the responsibility of the firm to reinstate the license. There is a \$500 reinstatement fee. If the reinstatement application is received by the VBOA **within** 12 months of license expiration, the date of the reinstatement, if approved, will be effective as of the date it expired. However, any reinstatement application received **after** 12 months of license expiration, the date of reinstatement will be effective as of the date the reinstatement application is approved. Please be aware that by signing this application on behalf of your entity, you are affirming that your entity's application is complete and correct and that on behalf of your entity you have read and understand and will remain current with the laws and regulations governing the practice of accounting in Virginia.
